### Supreme Court to Decide if Homelessness Can be Treated as a Crime

The Supreme Court's decision in Grant's Pass v. Johnson has implications for how the unsheltered are treated across the country.

For the first time in decades, the issue of homelessness has reached the country's highest court. The Supreme Court recently heard arguments on April 22nd in Grants Pass v. Johnson, and the court's final decision in the case could have national implications on how states and cities regulate their homeless populations and encampments.

Grants Pass is a small city in Oregon that, like many across the country, has a shortage of affordable housing and, in their case, also has no permanent shelter. The city prohibits sleeping in public and enforces this law with costly fines and 30-day jail sentences. This type of law isn't uncommon. In fact, according to the National Homelessness Law Center (NHLC), 15 states have similar laws and per NPR, Tennessee goes so far as to treat public sleeping as a felony punishable with up to six years in prison.

The issue for the Supreme Court is, are these laws in violation of the Eight Amendment which protects against cruel and unusual punishment? Many lower courts have concluded that people should not be prosecuted or punished for a situation that is more a consequence of a lack of affordable housing and high barriers imposed for securing any adequate housing that may be available. It becomes a "human rights" issue when someone's unsheltered status alone could make them criminal.

The National Low Income Housing Coalition found in 2023, "a national shortage of 7.3M affordable and available rental homes for low-income renters." These renters are defined as having income that is 30% of their area median income. This same organization cites New Jersey as having only 30 available and affordable rental units for every 100 extremely low-income renters seeking housing.

Instead of local and state governments investing in more affordable housing development, many are choosing to arrest and incarcerate people experiencing homelessness. Per NHLC, between 2006 and 2019, there was a 92% increase in citywide bans on camping, a 103% increase in loitering bans and a 213% increase in bans on living in vehicles. This trend toward criminalization is a decision that is costing taxpayers \$83,000 per person annually according to an article published by Vera.

Regarding the Court's decision, a New York Times article noted "the court appeared split along ideological lines in the case," with some feeling that the justices are leaning in support of Grants Pass. With the Court's term winding down, their decision in Grants Pass is expected to come at any time.

\*\*Since the article was written, The Supreme Court ruled in favor of Grants Pass. This decision will allow towns to arrest individuals for sleeping in a public place even when there are no other adequate shelter options provided.

### Hear Their Stories



Luke, a 31-year-old male, lived in his car after losing a limb in a lawn mower accident. Not only is he healing from the loss of his limb, but also from the trauma of not having a place to recover. Through our programs, FPSC sheltered him through our transitional housing program and intensive case management with a case manager. After being stabilized, Luke can now focus on his recovery and is beginning to learn to walk with a prosthetic while we search for housing that meets his needs.

# Blueberry Streusel Muffins

Prep time: 15 Minutes Cook time: 20 minutes Total time: 35 minutes Yield: 10 muffins



### For the streusel

¼ cup unsalted butter, melted

1/3 cup granulated sugar

2/3 cup allpurpose flour

### For the blueberry muffins

½ cup unsalted butter, melted 1 cup granulated sugar 2 eggs, room temperature

1 teaspoon vanilla extract

6 Tablespoons Greek yogurt 6 Tablespoons buttermilk

1 Tablespoon baking powder

½ teaspoon salt

2 cups + 2 Tablespoons all-purpose flour

2 cups blueberries, fresh or frozen

### Instructions

1.Preheat oven to 425°F. Grease 10 standard size muffin tins and line with cupcake liners. Set aside.

2.In a small mixing bowl, combine all the ingredients for the streusel, using a fork or a pastry cutter to stir together until the mixture resembles wet sand.

3.In a large mixing bowl combine the melted butter and granulated sugar, beating until combined. Add the eggs one at a time. Add the Greek yogurt, buttermilk, and vanilla extract.

4.Add 2 cups flour, baking powder, and salt. Mix until it begins to come together (not fully incorporated). Toss the blueberries with the additional 2 Tablespoons of flour. Fold the blueberries into the batter, mixing only until combined. Batter will be thick.

5. Scoop batter into prepared muffin tins, filling about 3/4 of the way. You can use a large cookie scoop or a 1/4 cup measure to keep things consistent.

6. Sprinkle the tops of each muffin with about 2 Tablespoons of the streusel mixture, pressing the streusel gently into the batter so it sticks.

7. Bake for 5 minutes at 425°F, then turn oven down to 375°F and bake for an additional 15 minutes, until muffins are golden brown and spring back to the touch.

8. Remove from oven and allow to cool for at least 15 minutes before eating!

### Local Seniors Face High Rents and Housing Insecurity

Seniors on a fixed income are struggling with increasing rent costs and rising inflation.



A rising number of seniors in northern New Jersey and across the nation are burdened by high housing costs, meaning they spend 30 percent or more of their income on housing. A 2023 study by Harvard University found 70 percent of seniors making \$25,000 or less spend 30 percent or more of their income on their monthly rent. For seniors with mortgages in the same income category, over 90 percent are burdened by housing cost. To put that into perspective, the Social Security Administration reports the average monthly Social Security retirement benefit as of January 2024 is \$1,907, which translates to only \$22,884 annually.

Additionally, income for seniors is covering less as cost-of-living expenses increase. A study by UMASS Boston found "the average Social Security benefit covers just 68% of basic living expenses of housing, food, transportation, and health care for a single renter in 2021." The research also shows the "gap between Social Security benefits and what it takes to get by is especially problematic for older adults who rely largely or entirely on Social Security, including nearly a quarter of adults aged 65 or older who depend on Social Security for 90% or more of their family income."

Seniors on a fixed income have also been facing a rise in rent prices. The Pew Research Center reported an 18 percent increase in rent between 2017 and 2022. Additionally, the current median cost of an apartment in Sussex County is \$1,900 a month according to Zillow. Availability of apartments is also limited, and current tenants often face rent increases from their landlords to keep pace with the market. Additionally, area waitlists for affordable senior housing are several years long.
